

China CITIC Bank International to raise USD prime rate

(Hong Kong: 13 June 2023) China CITIC Bank International Limited (“CNCBI”) today announces that the Bank is to increase its USD prime rate by 75 basis points, from 7.50% to 8.25%, effective from 15 June 2023.
