China CITIC Bank International to adjust HKD and USD prime rate as well as HKD savings rates

(Hong Kong: 11 November 2024) China CITIC Bank International Limited ("CNCBI") today announces that the Bank is to adjust its HKD and USD prime rates. The HKD prime rate is reduced by 25 basis points, from 5.875% to 5.625%, while the USD prime rate is lowered by 25 basis points, from 8.000% to 7.750%. The Bank's HKD savings rates are also adjusted. The above adjustments will become effective from 12 November 2024.
