China CITIC Bank International's statement on a fraudulent SMS message

(Hong Kong: 7 January 2025) China CITIC Bank International Limited ("CNCBI") would like to alert members of the general public and its customers to a fraudulent SMS message sent from an account named "inMotiom". The Bank wishes to declare that it has no connection with the fraudulent SMS message.

The abovementioned fraudulent SMS message from "inMotiom" consists of nine digits. It claims allegedly that an overdue payment is to be debited to the message recipient's account and requests that the message recipient tap the hyperlink embedded in the message should the message recipient wish to cancel the payment or contact customer service.

Please note that the Bank does not require customers to provide any sensitive personal information (including login IDs, passwords or one-time passwords) through telephone calls, voice messages, emails, SMS, social media platforms or online forums.

Meanwhile, the Bank has registered with the SMS Sender Registration Scheme set up by the Office of the Communications Authority and is a "Registered SMS Sender". Starting from 28 January 2024, all SMS messages from CNCBI will begin with the prefix "#", or specifically, carry one of the following registered SMS Sender IDs:

- #CNCBI
- #CNCBI INFO
- #CNCBI TXN
