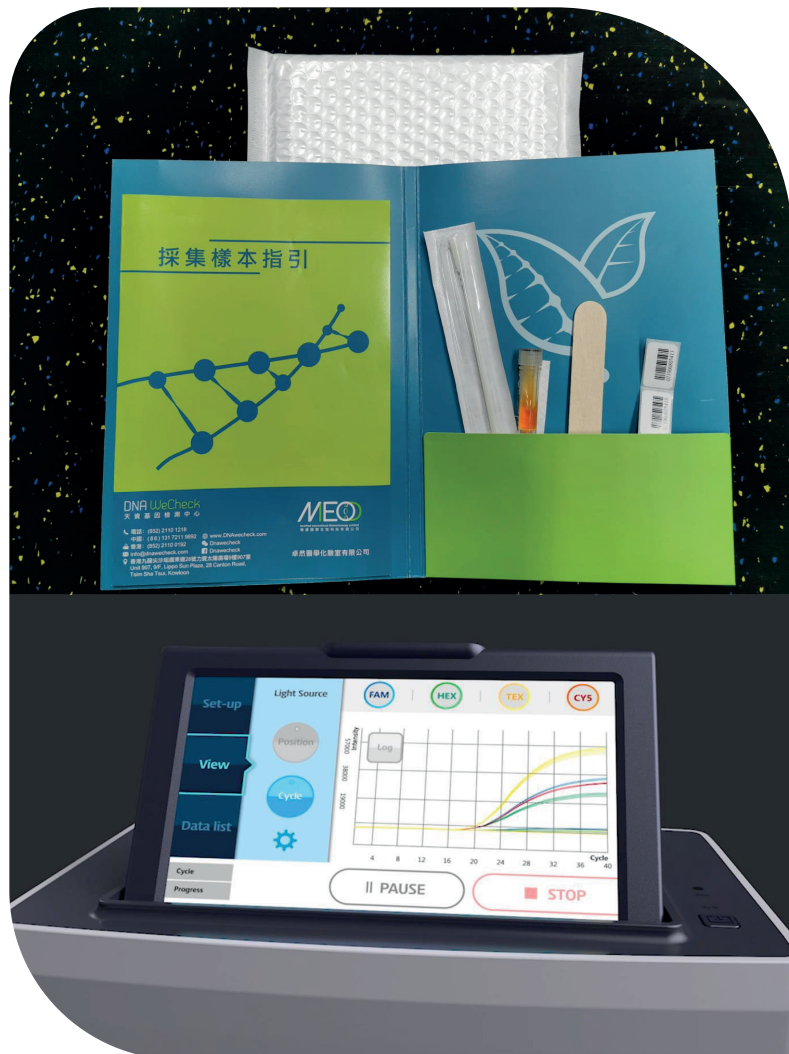

The New Coronavirus (COVID-19) Rapid Test

- A RNA test for accurate detection of infection during the incubation period when there is no symptoms – a major diagnostic method widely applied.
- The equipment has got CE and Korean official certification, and the microfluidic chip used for the test has patents in 17 countries around the world.
- Advanced technology – test will be completed in about half an hour once RNA is extracted.
- High sensitivity – require as low as 5-10 copies of RNA molecules to generate accurate results.
- Based on genetic sequence of the virus, target primers are designed to include both ORF and N regions, test specificity being reconfirmed.

Upon receiving the test kit, the customers should follow the instructions to collect sample in the pharynx at home, and then deliver the sample to the laboratory for testing. The report will be ready the next working day.
