

「<READY FOR> GIN LEE 李幸倪LIVE IN HONG KONG 2026」(「演唱會」) 信銀國際卡優先訂票
(「優先訂票」) 之條款及細則:

1. 優先訂票由 2025 年 12 月 11 日上午 10 時至 2025 年 12 月 12 日晚上 11 時 59 分或於全部優先訂票售罄前。
2. 優先訂票適用於所有持有由中信銀行(國際)有限公司(「銀行」)發出之信銀國際信用卡(信銀國際商務卡除外)及信銀國際多幣扣賬卡(「合資格卡」)之主卡及附屬卡會員(「會員」)(如適用)。
