

Terms and Conditions of MONOPOLY Deposit April 2025 Campaign (the "Campaign")

1. The Promotion Period is from 1 April 2025 to 31 July 2025, both dates inclusive.

Registration

- 2. The Registration Period for the Campaign is from 1 April 2025 to 30 April 2025 with a cut-off time 10pm, this period also refer as "Fund-in Period".
- 3. Customer can register the Campaign via inMotion or any branches.
- 4. Registration Date is the date that customer has successfully registered for the Campaign during the Registration Period according to the bank record. Registration Date for any registrations after 10pm (Monday to Friday) / 6pm (Saturdays) and during public holidays will be deferred to the next business day of the bank.
- Customer can use a valid Multi-currencies Statement Savings Account ("MCSSA") of the respective currency under sole name as the Registered Account to register the Campaign. MCSSA in joint name is not applicable for registration.
- 6. At any time, customer can only have **one** active MONOPOLY Deposit Campaign per currency.
- 7. By registering the Campaign, customer agrees to receive notifications regarding the Campaign via Push Notification, SMS and Email.

MONOPOLY Deposit Bonus Interest Rate

- 8. Bonus interest will be calculated daily based on the day-end Eligible Fund balance in the Registered Account.
- 9. Eligible Fund
 - During the Registration Period

Eligible Fund refers to the day-end New Fund amount placed in the registered account.

• After the Registration Period

Eligible Fund at the end of the Registration Period will be fixed as the maximum amount entitled for Bonus Interest Rate. If customer withdraw funds from the registered account, the Eligible Fund amount may be decreased.

10. New Fund

- New Fund is calculated based on the net increase of day-end Total Deposit balance* and the Total Deposit balance of the previous month's last business day, deducted by the sum of principal amount which has been entitled to new fund Time Deposit offer within the calendar month.
 - (*If that day is not a business day, the Total Deposit balance of the previous business day will be used)
- On any business day, any funds credited after 10pm on Mondays to Fridays or 6pm on Saturdays, or funds have not been cleared and become available balance on the day, will be considered as the net increase of Total Deposit for the next business day.
- Total Deposit includes balance in current accounts, savings accounts, One Account "Deposit" and time
 deposits opened, under sole name or joint name. Any debit balance in current accounts will be treated as zero.
- If the deposit involves foreign currency, the foreign currency exchange rate fluctuation may cause variation to the Eligible Fund amount. The equivalent amount in respective currencies will be calculated based on the exchange rate determined at the sole discretion of the Bank.

11. Bonus Interest Rates

 Subject to the Minimum and Maximum Eligible Fund amount stated in Clause 12, registered customer's Eligible Funds in the Registered Account could enjoy the respective currency's bonus interest rates as follows starting from the Registration Date within the promotion period:

• The bonus interest rates will be applied on top of the respective currency's prevailing savings rate. Bonus interests will be credited to the Registered Account monthly during the promotion period, along with the prevailing savings interests, on the last business day of each month.

12. Minimum and Maximum Eligible Fund

 The Minimum and Maximum Eligible Fund amount of each currency entitled to bonus interest rates during the Promotion Period:

- After registration, registered customer must meet the respective currency's minimum Eligible Fund Amount requirement in the Registered Account on at least one business day during the Registration Period to entitle to the applicable Bonus Interest Rates.
- If the Eligible Fund in the Registered Account has never met the respective minimum requirement from the Registration Date to the end of Registration Period, Eligible Fund in the Registered Account will not be entitled to Bonus Interest Rates. The registration will be cancelled automatically after the Registration Period ends.
- 13. After registration, customer can continue to deposit Eligible Funds into the Registered Account within the Registration Period / Fund-in Period.
- 14. After the end of Registration Period, any further new funds deposited in the Registered Account will not be entitled to the Bonus Interest Rate.
- 15. The Bank reserves the right of final decision should there be any dispute in the definition of "Eligible Fund" and "New Fund".

General Terms and Conditions

- 16. The Bank reserves the right to delete, replace, supplement or amend any of these Terms and Conditions without prior notice, and shall not be responsible for any costs, expenses, losses or liabilities incurred. In the event of any matter or dispute arising out of or in connection with the offer of the Campaign, the decision of the Bank shall be final and conclusive.
- 17. Fraud and abuse will result in forfeiture of a customers' eligibility to participate in these offers as well as cancellation of the accounts.
- 18. Except as otherwise expressly stated in these Terms and Conditions, no one other than a party to these Terms and Conditions may enforce any of their terms under the Contracts (Rights of Third Parties) Ordinance, Cap. 623 of the Laws of Hong Kong. Where any clause of these Terms and Conditions entitles any third party to enforce any term of these Terms and Conditions under the Contracts (Rights of Third Parties) Ordinance, the parties reserve the right to vary that term or any other term of these Terms and Conditions without the consent of that third party.
- 19. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and any dispute arising out or in connection therewith shall be referred to the courts of Hong Kong SAR.
- 20. In the event of any inconsistency between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.

登記
