

Terms and Conditions for CNCBI Credit Card X Wing On Travel Promotion Offer ("Offer")

- 1. Unless otherwise indicated by China CITIC Bank International Limited ("CNCBI"), the promotion period is valid from 8 July to 31 December 2024 (both dates inclusive) ("Promotion Period").
- 2. During the Promotion Period, CNCBI GBA Dual Currency Credit Card ("Eligible Credit Card") Cardmembers ("GBA Cardmembers") can enjoy double offer on designated hotel bookings ("Hotel Offer") and HK\$20 discount on high-speed rail ticket upon single order of HK\$200 or above ("High-Speed Rail Offer"). Hotel Offer includes i) instant 9% off and ii) up to 50% cash rebate. Instant 9% off and up to 50% cash rebate can be enjoyed in conjunction. GBA Cardmembers are entitled to a maximum of HK\$200/order under instant 9% off offer and a maximum of HK\$500/order under 50% cash rebate offer.

Hotel Offer is applicable to the designated hotels in Guangzhou, Shenzhen, Zhuhai, Zhongshan, Dongguan, Huizhou, Jiangmen, Foshan, Zhaoqing available at Wing On Travel (the "Merchant") and with latest check-in date of 31 January 2025. High-Speed Rail Offer is applicable to the train departed from or arrived at Hong Kong West Kowloon Station available at the Merchant's. The Merchant will refresh the promotional code ("Designated Promotional Code") at 10:00am on the 8th calendar day of each calendar month. The validity period of each promotional code is one month, from 10:00am on the 8th calendar day of each calendar month to 09:59am on the 8th calendar day of next calendar month ("Each Stage"). GBA Cardmember shall register as the Merchant's member via the Merchant's website (https://www.wingontravel.com) or mobile application ("Wing On Travel App"), then make order of designated hotel or high-speed rail booking via the Merchant's website or Wing On Travel App by the Eligible Credit Card and input the Designated Promotional Code of the month before payment to enjoy the Offer ("Eligible Spending"). The Offer is available on a first come first served basis while stock last. During Each Stage, GBA Cardmember is entitle to redeem the Designated Promotional Code once only, which means Hotel Offer and High-Speed Rail Offer can be enjoyed once only in Each Stage.

Up to 50% cash rebate will be calculated based on net transaction amount of Eligible Spending and to be credited to Eligible Credit Card account by 28 Feb 2025 and be shown in next monthly statement. CNCBI reserves the right to determine GBA Cardmember's entitlement to 50% cash rebate. This up to 50% cash rebate is only applicable to GBA Cardmembers whose relevant Card account is determined by CNCBI (in its sole and absolute discretion) to remain valid, in good standing, is not cancelled or terminated at all times during the entire Promotion Period and at the time of fulfillment. Otherwise CNCBI may terminate the cash rebate for such GBA Cardmember without any prior notice.
