

## **信銀國際 – Food Panda 額外 HK\$300 現金回贈之條款及細則**

1. 除特別註明外，新客戶於2023年5月20日至2023年6月4日（包括首尾兩天）（「推廣期」）透過指定連結 [www.cncbinternational.com/dsl04](http://www.cncbinternational.com/dsl04) 成功申請信銀國際Motion信用卡（「信用卡」）及於2023年6月30日內成功批核及啟動新卡可享額外HK\$300現金回贈（「額外現金回贈」）。
