

\$mart Plus Tax Season Loan – Promotional Terms and Conditions for Upto 5 Months Interest Rebate Offer:

Eligible Customers' Loan Account must be valid and in good condition without any late payment or early repayment at the time the Interest Rebate is given, otherwise the Bank reserves the right to cancel the Interest Rebate.
- 5. The Interest Rebate is not exchangeable, transferable or redeemable for cash.
- 6. An Eligible Customer shall enjoy the Interest Rebate Offer once only during the Promotion Period. The Interest Rebate Offer shall not be used in conjunction with other promotion offers at the same time.
