

Smart Plus Personal Installment Loan – Promotional Terms and Conditions for “Up to HK\$13,888 Cash Rebate Offer” and “Exclusive Limited-Time Reward – Extra HK\$2,000 Cash Rebate”:

- These promotional terms and conditions are applicable to customers successfully applying and drawdown for Smart Plus Personal Installment Loan including Personal Instalment Loan, Debt Consolidation and Top Up Loan (“Loans”) from China CITIC Bank International Limited (the “Bank”) with loan amount of HK\$100,000 or above and repayment tenor of 36 months or above during the designated promotional period (“Eligible Customers”). Offers are detailed below:

a) Up to HK\$13,888 Cash Rebate Offer:
