

HKD10,000 Super Draw exclusive for CITIC*first* customers (“Super Draw”) Terms and Conditions

1. Unless otherwise indicated by China CITIC Bank International Limited (the “**Bank**”), the promotion period is from 24 June 2020 to 31 August 2020 (both dates inclusive) (“**Promotion Period**”). This Super Draw is subject to applicable Terms and Conditions of the Bank, including the Terms and Conditions for Deposit Accounts, Terms and Conditions for i-banking and Terms and Conditions for inMotion (the “Promotional Terms and Conditions”).
2. Eligible Customer (as defined in clause 3 below) is entitled to participate in the Super Draw by earning chances (the “**Super Draw Chance**”) to win the prize.
3. **The Super Draw is applicable to customers of the Bank who have fulfilled the following requirements (“Eligible Customer”) during the Promotion Period. Eligible Customer with each fund transfer (HK\$30 or above per transaction) through Faster Payment System (“**FPS**”) via the Bank’s mobile application - inMotion Services (“**inMotion**”) will be entitled to one (1) **extra** Super Draw Chance. Eligible Customer is entitled to a maximum of one (1) Super Draw Chance on every calendar day during the Promotion Period, i.e. a maximum of sixty-nine (69) extra Super Draw Chances during the Promotion Period. All relevant transactions, based on the transaction date, must be conducted during the Promotion Period.

8. The Bank has the sole and absolute authority in determining if Eligible Customer’s FPS transaction and Cash Payout Transfer are successful and eligible for the purpose of this Super Draw.
9. The Super Draw Prize will be credited to the Winners’ HKD deposit account of the Bank **on or before 31 October 2020** without prior notice.
10. Winner must hold a valid HKD deposit account and his/her CITIC*first* status on the date when the Super Draw Prize is credited, otherwise, the Super Draw Prize shall be forfeited absolutely and shall not be paid to the Winner through any other means.
11. No part of this Super Draw Prize is transferable, exchangeable, returnable or redeemable for cash.

The Bank reserves the right to delete, replace, supplement or amend any of these Promotional Terms and Conditions without prior notice, and shall not be responsible for any costs, expenses, losses or liabilities incurred in the event of any matter or dispute arising out of or in connection to this Super Draw, the decision of the Bank shall be final and conclusive.

Except as otherwise expressly stated in these Promotional Terms and Conditions, no one other than a party to these Promotional Terms and Conditions may enforce any of their terms under the Contracts (Rights of Third Parties) Ordinance, Cap. 623 of the Laws of Hong Kong. Where any clause of these Promotional Terms and Conditions entitles any third party to enforce any term of these Promotional Terms and Conditions under the Contracts (Rights of Third Parties) Ordinance, the parties reserve the right to vary that term or any other term of these Promotional Terms and Conditions without the consent of that third party.
17. These Promotional Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and any dispute arising out or in connection therewith shall be referred to the courts of Hong Kong SAR.
18. In the event of any inconsistency between the English and Chinese versions of these Promotional Terms and Conditions, the English version shall prevail.
