

## Terms and Conditions of inMotion Login HKD50 Cash Reward (“Cash Reward”)

1. Unless otherwise indicated by China CITIC Bank International Limited (the “Bank”), the promotion period is from 1 November 2020 to 20 February 2021 (both dates inclusive, hereinafter called the “Promotion Period”).
