

## **Terms and Conditions of inMotion HK\$200 Limited Time Offer Promotion (“HK\$200 Limited Time Offer Promotion”)**

1. Unless otherwise indicated by China CITIC Bank International Limited (the “**Bank**”), the promotion period of HK\$200 Limited Time Offer Promotion is from 00:00 (HKT) on 1 May 2022 to 23:59 (HKT) on 30 Jun 2022 (both dates inclusive, the “**Promotion Period**”). This HK\$200 Limited Time Offer Promotion is subject to applicable Terms and Conditions of the Bank, including the General Terms and Conditions, the Terms and Conditions for inMotion, Terms and Conditions for Deposit Accounts and Terms and Conditions for ibanking.
2. Except as otherwise expressly stated by the Bank, only a **new customer** who has not maintained any account or service with the Bank within the preceding 12 months can join the HK\$200 Limited Time Offer Promotion.
3. **The new customer is eligible for the HK\$200 cash reward (“Cash Reward”) if ALL the following conditions are fulfilled (“Eligible Customer”):**
  - i. Must input the unique promotion code – **2FLY4M0422** (“**Promotion Code**”) during the submission of Multi-Currencies Statement Savings Account (“**MCSSA**”) application via inMotion (“**inMotion Application**”); and
  - ii. The inMotion Application must be submitted successfully during the Promotion Period; and
  - iii. Must successfully open MCSSA and i-banking account via inMotion on or before 14 July 2022 23:59 (HKT); and
  - iv. The relevant MCSSA and valid i-banking accounts have not been cancelled at the time the Cash Reward is given.
4. The Eligible Customer is required to ensure the accuracy and validity of the information provided, including the Promotion Code inputted during the inMotion Application. Once the inMotion Application is submitted, the record cannot be amended. In the case where, according to the Bank’s records, the information provided, including but not limited to the Promotion Code in the inMotion Application, does not reconcile with the records of the Bank’s system, or are otherwise incorrect, the Eligible Customer will not be given the Cash Reward.
5. Each Eligible Customer will be entitled to the Cash Reward once only during the Promotion Period.
6. This eligibility of HK\$200 Limited Time Offer Promotion is subject to the Bank (in its sole and absolute discretion) verification and confirmation.
7. The Cash Reward will be credited to the Eligible Customer’s MCSSA of the Bank in our absolute discretion on or before 30 September 2022 23:59 (HKT) without prior notice. The Eligible Customer must hold valid i-banking accounts AND valid accounts mentioned in this clause and in good standing during the Promotion Period and at the time of fulfillment. If the account status changes, the Bank reserves the right to terminate the Cash Reward to the Eligible Customer, without prior notice.

8. This HK\$200 Limited Time Offer Promotion cannot be used in conjunction with other referral reward promotion/ programme of the Bank, including but not limited to inMotion MONOPOLY Referral Reward Programme Promotion.
9. No part of this Cash Reward is transferable, exchangeable, returnable or redeemable for cash.
10. The HK\$200 Limited Time Offer Promotion is not applicable to the Bank's staff.
11. Eligible Customers who participating in the HK\$200 Limited Time Offer Promotion represent their understanding of, acceptance and willingness to comply with these Terms and Conditions. The availability or redemption of some benefits, schemes or arrangements may be governed for further terms and conditions specified by us from time to time. In case of any breach of these Terms and Conditions, or any dishonest conduct and/or acts of counterfeit, the Bank reserves the absolute right to immediately cancel the Eligible Customer's entitlement to the Cash Reward and pursue any violations without prior notice.

The Bank reserves the right to adjust, withdraw or cancel HK\$200 Limited Time Offer Promotion and to delete, replace, supplement or amend any of these Terms and Conditions from time to time without prior notice. The Bank shall not be responsible for any costs, expenses, losses or liabilities incurred in the event of any matter or dispute arising out of or in connection this HK\$200 Limited Time Offer Promotion, the decision of the Bank shall be final and conclusive.

Except as otherwise expressly stated in these Terms and Conditions, no one other than a party to these Terms and Conditions may enforce any of their terms under the Contracts (Rights of Third Parties) Ordinance, Cap. 623 of the Laws of Hong Kong. Where any clause of these Terms and Conditions entitles any third party to enforce any term of these Terms and Conditions under the Contracts (Rights of Third Parties) Ordinance, the parties reserve the right to vary that term or any other term of these Terms and Conditions without the consent of that third party.
14. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and any dispute arising out or in connection therewith shall be referred to the courts of Hong Kong SAR.
15. In the event of any inconsistency between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
