

## <u>Terms and Conditions of Cross-border Life in Motion: CNCBI GBA Dual Currency Credit Card Extra Welcome Rewards Promotion (the "Extra Welcome Rewards Promotion")</u>

- 1. The promotion period of the Extra Welcome Rewards Promotion is valid from 6 January 2025 to 31 March 2025 (both dates inclusive) (the "**Promotion Period**").
- The Extra Welcome Rewards Promotion is applicable to applicants who do not currently hold the principal card of CNCBI GBA Dual Currency Credit Card (the "Eligible Credit Card") (the "Eligible Applicant(s)").
- 3. To be eligible for the extra welcome rewards (the "Extra Welcome Rewards"), Eligible Applicants are required to apply for the Eligible Credit Card by submitting a designated credit card application form via inMotion with "GBATK" being inputted in the field of promotion code during the Promotion Period (the "Eligible Application").
- 4. The Extra Welcome Rewards consist of the following 2 parts:
  - Eligible Credit Card application submission reward
    Eligible Applicant can choose one of the followings in the Eligible Application as application submission reward (the "Application Submission Reward"):

The e-coupon code of the Application Submission Reward (the "e-Coupon Code") will be sent via SMS to the mobile number provided in the Eligible Application within 10 working days after the successful submission of the Eligible Application. The e-Coupon Code will not be re-issued for any reason (e.g. loss or stolen) once issued. To enjoy instant discount at the value as stated in Clause 4 (i) above, Eligible Applicant is required to register or login as KLOOK member via KLOOK's webpage or Mobile application and purchase the selected Application Submission Reward with the e-Coupon Code on or before 31 December 2025. Shall there is any price adjustment for the selected Application Submission Reward, the Eligible Applicant is required to pay for the price difference with the Eligible Credit Card without prior notice. - 6. The Application Approval Reward will be credited to the Eligible Credit Card Hong Kong Dollars account on or before 30 June 2025 and will be shown on the credit card monthly statement. The Application Approval Reward received under the Extra Welcome Rewards Promotion can only be used to offset future retail purchase transactions and cannot be used to settle any outstanding statement balance. The relevant Eligible Credit Card account must remain valid and in good standing during the Promotion Period and at the time when



the Application Approval Reward is credited. Otherwise the Bank has the right to forfeit the Application Approval Reward without prior notice.

- 15. These Terms and Conditions shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and any dispute arising out or in connection therewith shall be referred to the courts of Hong Kong Special Administrative Region.
- 16. In the event of any inconsistencies between the English and Chinese versions of these Terms and Conditions, the English version shall prevail.
